# CANADIAN CHURCH OF GOD MINISTRIES – GRACEPOINT CHURCH, EDMONTON

Thanks for the opportunity to be one of the Wetaskiwin Church of God representatives at Leader Connect 2019 -AGM and participate in the larger church body within the COG in western Canada. It was good to meet many familiar and new fellow church workers/pastors serving the Lord in the various churches and programs.

This time started in study and prayer with sessions on the "Path of Revival" by Mark Barnard of Blessingpoint Ministries, Inc. It was a great beginning for these meetings as the important business of listening, hearing and seeking the Lord happened before addressing the practical application side of the business.

The topic, **THE PATH OF REVIVAL** followed the instruction found in: 2 Chronicles 7:14 "If my people, who called by my name will humble themselves, and pray, and seek my face, and turn from their wicked ways, then will I hear from heaven and forgive their sin and heal their land."

This Scripture was used to teach about God's view of the nature and need of Corporate revival in the nation of Israel and its application for us today setting out the conditions of God's blessing for His people corporately. After each session participants gathered in small groups to discuss pertinent questions and pray together spending about 15 minutes per each of 5 breakout sessions.

The Nature of Corporate Revival in the OT – God spoke after a Solemn Assembly at the dedication of Solomon's temple where nearly the entire nation was present when the glory of the Lord filled the temple, given in a night-time appearance to King Solomon as head of the nation. The Lord describes His future policy toward the nation of Israel and set out the conditions of God's re-blessing of His people as a whole entity.

The Nature of Corporate Revival in the NT – Rev. 2 & 3 Each congregation was held accountable for its condition. Jesus called the majority of those churches to report as corporate entities. This is not the typical way we think. We tend to look at our churches as gatherings of individuals who voluntarily meet together but Jesus sees our church as a spiritual entity. He holds the church accountable for its corporate condition.

- Corporate revival addresses spiritual roadblocks to God's blessing on the church's ministry. It's not talking about tweaking a church's program.
- Just as sin hindered God's blessing on the nation of Israel, sins and wounds in the body of Christ hinder God's blessing on local churches.

The Path of Revival is restoring Our nation – One church at a time - There are four ways of seeing a Church: 1) the way a church sees itself 2) the way others see the church 3) the way a church thinks others see it 4) the way God sees a church.

We may define our corporate identity in ways that have nothing in common with the way Jesus appraises us. Several of the churches addressed in Rev. 2 & 3 were doubtless shocked to discover the gap between their corporate self perception and Jesus' appraisal of them.

William Wilberforce (Real Christianity. P. 166) quote, "We need to see our true state as God sees it. Because of His perfect purity and His ability to know us better than we know ourselves, it is likely that He sees problems and failures we are barely conscious of - if we recognize them at all."

An Oft-Ignored Biblical Truth: - There are many cases where God does not forgive corporate sin until those in leadership take responsibility and repent. (Examples - The kings of Israel and the sins of Jeroboam – resulted in the cycle of Judges. (2Kings 10:28-30); Discipline and judgment can occur long after the sin. (2 Sam. 21: 70 yr. exile); Present enlightenment does not erase past corporate or leadership sinfulness .(Matt.23:29-32)

2 Chronicles 7:14 "...then will I hear from heaven and forgive their sin and heal their land." When is "then" – it refers to a point in time when God's attitude and disposition toward His people changes. In that moment a church/ministry receives a new spirit.

The occasion at which God unleashes His corporate blessing is a gathering where a congregation rights its relationship with God. The event where we transact such serious spiritual business is known as a solemn assembly.

The elements of a Solemn Assembly –

- 1. Hope
- 2. Corporate Covenant
- 3. Public Confessions and Mediatorial Authority
- 4. Resolution of the Problem
- 5. Resistance
- 6. Real and Symbolic Acts of Repentance
- 7. Courageous Action

Each church is now left facing the challenge of the question:

Are you willing to address whatever stands between your church and revival?
